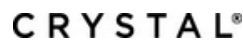
From 1 January 2025, CLIA Travel Agents across Australia and New Zealand will have access to the 2025 CLIA AUSTRALASIA TRAVEL AGENT REWARDS PROGRAM via the CLIA Members Hub.

The 2025 rewards program provides every CLIA Travel Agent in Australia and New Zealand with the opportunity to earn their membership fee back many times over by redeeming all reward offers on eligible bookings made with participating CLIA cruise lines between 01 January and 31 December 2025. The rewards are paid either as extra commission, a rebate or a gift card, depending on the cruise line. Each offer can be redeemed only once per agent and is non-transferable.

Through this program, CLIA Membership can pay for itself – many times over!

Rewards are limited to one redemption per CLIA Travel Agent and every consultant listed in your CLIA Travel Agency Membership profile has access to the Rewards Program. Terms and conditions apply for each individual cruise line reward.

*\$2000 is calculated based on the combined minimum indicative value of all CLIA Cruise Line rewards available on eligible new cruise bookings made in 2025. You must be a CLIA Australasia Travel Agent to redeem each reward and you will have access to the Rewards Program from 1 January 2025, once payment for your 2025 CLIA Membership has been processed. Access to the 2025 CLIA Australasia Travel Agent Rewards Program will be given to a CLIA Travel Agent/Agency that joins or renews their CLIA Membership, and has paid the annual membership fee. All rewards are redeemable once per CLIA Travel Agent on an eligible booking and are not transferable. The full program of rewards are available to all consultants listed under the Travel Agency's CLIA Membership. Terms and conditions apply for each Cruise Line offer.
